Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water. Our water source is primarily from one active ground water well located within our service area and supplemented by water from Silver Springs Rural Water System as needed.

If you want to learn more, please attend any of our regularly scheduled Town meetings. They are held in the North Town Hall court room at 7pm on the second Monday each month.

The Town of North routinely monitors for contaminants in your drinking water according to Federal and State laws. This table shows the results of our monitoring for the period January 1st to December 31st, 2015. As water travels over the land or underground, it can pick up substances or contaminants such as microbes, inorganic and organic chemicals, and radioactive substances. All drinking water including bottled water may be reasonably expected to contain at least small amounts of some contaminants. It's important to remember that the presence of these contaminants does not necessarily pose a health risk.

In this table you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

Non-detects (ND) - Laboratory analysis indicates that the constituent is not present.

<u>Parts per million (ppm) or Milligrams per liter (mg/l)</u> - One part per million corresponds to one minute in two years or a single penny in \$10,000.

<u>Parts per billion (ppb) or Micrograms per liter</u> - One part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

Picocuries per liter (pCi/l) - Picocuries per liter is a measure of the radioactivity in water.

Action Level (AL) - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

<u>Maximum Contaminant Level (MCL) (mandatory language</u>) - The "Maximum Allowed" (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

<u>Maximum Contaminant Level Goal (MCLG) (mandatory language)</u> - The "Goal" (MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

MCLs are set at very stringent levels. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

All sources of drinking water are subject to potential contamination by substances that are naturally occurring or man made. These substances can be microbes, inorganics or organic chemicals and radioactive substances. All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk.
