

Mayor Julius Jones:

- Called the regular meeting of Council to order at 7:00 p.m. Present were Councilmembers Jeff Washington, and Jennifer Williams. Councilmember Wanda Whetstone came in at a later time.
- Mayor Jones amended the agenda to include an executive session regarding the Town's Mueller water system after the Mayor's report.
- Led Council and visitors in the Pledge of Allegiance.
- Declared quorum and welcomed all.
- Requested a motion to approve Council Minutes for August 10, 2020. Councilmember Washington motioned; Councilmember Whetstone seconded motion. All in favor. Motion passed.
- Requested a motion to approve Emergency Council Minutes for August 19, 2020. Councilmember Washington motioned; Councilmember Williams seconded motion. All in favor. Motion passed.
- Requested a motion to approve Emergency Council Meeting Minutes for September 4, 2020. Councilmember Washington motioned; Councilmember Williams seconded motion. All in favor. Motion passed.
- Welcomed Chief Lin Shirer to share the Police Report.

Chief Lin Shirer with the Police Report:

- Two recent shootings – both isolated events, not random shootings.
- In reference to Halloween, police will be doing an activity for Halloween and ask for donations to deliver candy to kids in town.
- License checks next 30 days.
- Discussion on new police car, having it completely outfitted; old car auction, details to be released soon.

Mayor Julius Jones on New Business:

- Financial reports. Asked if there were any questions. There were none.
- MASC Home Town Development Grant Resolution 2020-01.
 - Councilmember Whetstone made a motion to approve resolution. Councilmember Washington 2nd motion. All in favor. Motion passed.
- Census update for Orangeburg county (51%), State (58%), North (41.7%).
- A special election for Woodford will be held September 29th, 2020, at North's Town Hall. This election is for Woodford residents only.
- General election will be in November 3rd, 2020. No changes in the polling sites.
- Ditches on Hwy 321 were recently cleaned out by SCDOT on August 26th, 2020. Timely response and job well done. Helps prevent flooding from heavy rains.
- Citizen cleaned up around the Pavilion area on September 7th, 2020.
- Requested a motion to go into executive session.

- Councilmember Washington made motion to enter into executive session. Councilmember Williams 2nd motion. All in favor. Unanimous. Executive session began at 7:21pm.
- Entered back into regular session at 7:26pm. No decision was made.
- Mayor Julius Jones opened the floor for Council Projects:
 - Councilmember Whetstone did not have an update.
 - Councilmember Williams stated that her project was in process.
 - Councilmember Washington did not have an update.

Mayor Jones asked for a motion for adjournment:





- Councilmember Jackson made motion to adjourn; motion seconded. All in favor. Unanimous. Meeting adjourned at 7:30PM.
